NOTICE OF PROPOSALS

Hyndland, Hughenden and Dowanhill West

(traffic management and parking controls) order 201_

Glasgow City Council proposes to consider the introduction of the above named Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984.

The roads affected by these proposals are generally bounded by:

Great Western Road to the North; Crown Circus and Victoria Circus to the East; the Railway line and the eastern boundary of Gartnavel Hospital to the West and Banavie Road (where it becomes Peel Street) to the South.

Waiting and loading restrictions on Clarence Drive will also extend to its junction with Crow Road / Broomhill Drive outwith the Restricted Parking Zone extents. Shared use parking spaces will be provided on this section immediately west of the railway bridge only, as additional parking provision is required in order to cater for demand. Additional waiting and loading restrictions are also being proposed outwith the Restricted Parking Zone on Broomhill Drive, Crow Road, Fairlie Park Drive, Laurel Street, Marlborough Lane South, Monkscroft Avenue and Monkscroft Court.

Details of the proposals are as follows:

- A Restricted Parking Zone (RPZ) throughout most residential areas
- Shared use parking bays Monday to Saturday, 8am - 6pm for permit holders or those who wish to pay to park
- Pay & display parking bays Monday to Saturday, 8am - 6pm for those who wish to pay to park (Lismore Road only)
- Loading only places, Monday to Saturday, 8am - 6pm, to allow for loading and unloading by any class of vehicle
- 5. Disabled parking bays for disabled badge holders only
- 6. Motorcycle parking bays for solo motorcycles only
- 7. Car club parking bays for car club vehicles only
- 8. Electric vehicle bays for electric vehicle charging only (permits would not apply, 3 hours maximum stay)
- 9. Bus parking bay for buses only, Monday to Sunday, 8am 6pm
- 10. No waiting and no loading/unloading at any time
- 11. No waiting at any time
- No waiting Monday to Saturday, 8am 6pm,
 No loading Monday to Saturday, 8am 9.30am
 and 4pm 6pm
- 13. No waiting at any time restrictions, except permit holders Thursday 6pm – Thursday 8am in Airlie Lane (south section) and Lauderdale Lane (south section)
- 14. No waiting at any time restrictions, except permit holders Saturday 6pm – Saturday 8am in Great Western Terrace Lane, Kensington Gate Lane and Montague Lane
- Two way operation on Victoria Circus, between Linfern Road and Kensington Road
- 16. One way operation
- 17. Prohibition of entry

- 18. Prohibition of left turns
- 19. Prohibition of right turns
- 20. Prohibition of driving except for cycles
- Prohibition of vehicles except for emergency service vehicles and cycles
- 22. Taxi rank at Broomhill Drive relocated to south side of road and increased from 1 up to 3 taxi capacity
- 23. Resident parking permits at a cost of £85 per annum or £23.75 quarterly
- 24. Business parking permits at a cost of £650 per annum
- 25. Residents' visitor parking permits at a cost of £2 for a set 6 hour period
- 26. Resident and business permit holders would be able to park without limit of time
- 27. Those who wish to pay to park during chargeable hours would be subject to a parking charge of 20p for every 15 minutes for the first hour then 40p for every 15 minutes thereafter up to a maximum stay time of 3 hours
- 28. The payment method would be by using a pay and display machine and displaying a ticket or by a cashless mobile phone payment system.
