## SOUTH CITY WAY CONSULTATION EVENTS

As you may be aware, South City Way is a proposed active travel corridor between Queen's Park and the City Centre, the first phase of which is now in construction. South City Way was the winning project in the 2016 Community Links Plus funding competition organised by Sustrans and the Scottish Government, attracting £3.25m of external funding towards the scheme, with the City Council also contributing £3.25m. Many consultation events have taken place during the last 18 months, for example: public events during the bid stages of the funding competition; community consultations throughout the design stages; and, targeted consultation with transport operators and disability groups. Two further public events are now planned.

An event on 14 May 2018 will provide information regarding the proposed Traffic Regulation Order (TRO) for the Queen's Drive to Cumberland Street section, which predominantly seeks to amend parking and loading restrictions along the route. At the consultation event, anyone can drop-in to speak to Council officers, design engineers and representatives from our funding partner Sustrans. The TRO proposals will also be available on-line from 08 May 2018, visit [www.glasgow.gov.uk/proposedtro](http://www.glasgow.gov.uk/proposedtro).

The following day, a different consultation event is being held. This event is specifically targeted at the Gorbals Street section of South City Way. Two options are being presented and public feedback is requested as to which would be the preferred option.
