

### South City Way - Gorbals Street order 201\_

Glasgow City Council proposes to consider the introduction of the above named Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984.

The order proposes to implement a two way cycle track adjacent to the existing footway along Gorbals Road from Cumberland Street to Clyde Street in line with the current Strategic Plan for Cycling. The order will provide cycle and pedestrian priority to encourage sustainable transport and prioritise these options to assist in the delivery of the national Cycling Action Plan for Scotland and the targets from the Climate Change (Scotland) Act 2009.

The list of roads affected by these proposals are:

Gorbals Street, Victoria Bridge

This Order would propose the following:

1. Provision of Loading Only Places Monday to Sunday, 7am to 7pm on Gorbals Street
2. Parking Places Pay and Display during Monday to Saturday, 7am to 7pm on Gorbals Street
3. Provision of a disabled vehicles parking place on Gorbals Street
4. Provision of Motorcycle parking places on Gorbals Street
5. Provision of a northbound bus-only route 7am to 7pm on Gorbals Street from Cumberland Street for a distance of 35 meters
6. Prohibition of driving except pedal cycle between Cumberland Street to Clyde Street
7. Prohibition of being in a Two Way Cycle Track between Cumberland Street and Clyde Street
8. Ban the right turn from Gorbals Street to Cleland Street northbound
9. Ban the left turn from Gorbals Street to Cleland Street southbound
10. Amendments of no waiting at any time, no loading or unloading at any time and prohibition of being in a contra-flow bus lane on Gorbals Street.
