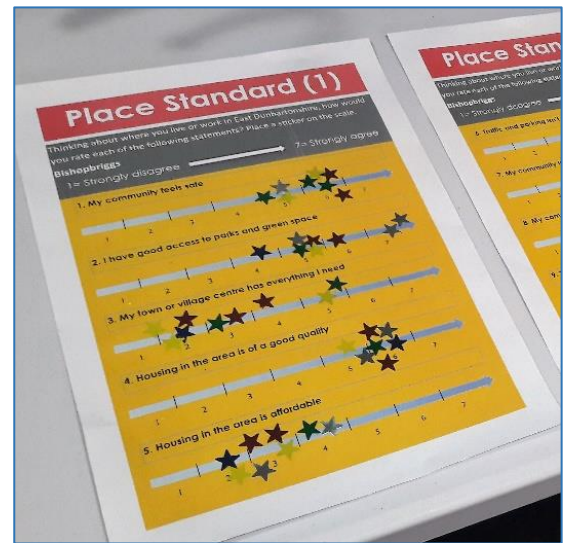

Local Development Plan 2 – Update

The Council is continuing to work on producing a Main Issues Report (MIR) for East Dunbartonshire following [Early Engagement between December 2018 and February 2019](#). Our intention is to publish this by the end of the year. More information will be provided in a future newsletter and you can view full details of our overall LDP timetable in the most recent [Development Plan Scheme](#).



Draft Local Transport Strategy

The Council has been working to produce a new Local Transport Strategy for the area which will set out the Council's transport strategy, Transport Planning Objectives and a series of actions and interventions to enhance transport and travel across East Dunbartonshire.

The Council undertook a period of consultation earlier this year on the Transport Options Report which was the initial stage of producing a new Local Transport Strategy. The comments and responses that were gathered during this period were collated by the Council and the findings were fed into the development of a Draft Local Transport Strategy 2020-2025.



The Draft Local Transport Strategy is being considered at the Council's Place, Neighbourhood and Corporate Assets Committee for approval on Thursday 29 August. Pending approval by the Committee, it is anticipated that the Council will hold a further period of consultation on the Draft from mid-September to mid-November. This consultation period will allow the Council to present what has been agreed for inclusion in the Draft Local

Transport Strategy and will welcome final comments in order to assist the Council in producing a final strategy for publication and implementation.
