

Local Development Plan 2 – Main Issues Report

The Council is currently preparing a new Local Development Plan (LDP) for the area – LDP 2. LDP 2 will guide the future use of land in East Dunbartonshire by setting out planning policies and identifying sites for development and protection.

As part of this process the Council undertook a period of early engagement between December 2018 and February 2019 on the key issues and priorities for LDP 2. The comments and responses gathered during this period were collated by the Council and summarised in a Report of Consultation, which, pending approval, will be published. These findings have been fed into the development of a Main Issues Report.



The Main Issues Report (MIR) is a key step towards the preparation of LDP 2. It will set out a series of preferred options for future development throughout East Dunbartonshire, across a range of planning issues. The MIR will also include a number of 'reasonable alternative options' for each issue.

The MIR is being considered at the Council's meeting on Thursday 26th September 2019 in the Tom Johnston Chamber at Southbank Marina (Council Headquarters). Pending approval, it is anticipated that the Council will then hold a period of public consultation on the MIR from mid-October to mid-December 2019.
