## NOTICE OF PROPOSALS

### St Andrews Drive

#### (Sustainable Transport Route) Order 202\_

Glasgow City Council propose to consider the introduction of a Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984.

**The main features of the proposals are:**

1. **Prohibition of waiting at anytime**, together with prohibition of being in a two way cycle track on the south and east kerbline of St Andrews Drive from the junction of Shields Road to the junction of Titwood Road.
2. **Corner/Junction protection** on the north and west side of St Andrews Drive, no waiting for a distance of 10 metres from junction of the on the following roads, St Andrews Crescent, Maxwell Drive, Nithsdale Road, Hamilton Avenue, Sutherland Avenue, Springkell Avenue, Sherbrooke Avenue, Terregles Avenue, Titwood Road, this will be in operation 24 hours a day, 7 days a week.
3. **Corner/Junction protection**, on both sides, no waiting for a distance of 10 metres from the junction with St Andrews Drive on the following roads, St Andrews Crescent, Maxwell Drive, Albert Drive, Aytoun Road, Nithsdale Road, Dalziel Drive, Hamilton Avenue, Sutherland Avenue, Springkell Avenue, Sherbrooke Avenue, Terregles Avenue, Titwood Road, this will be in operation 24 hours a day, 7 days a week.
